Dear Parents and Carers,

Re: 2022 Parent Payments - Year 5

Canterbury Primary School is looking forward to another great year of teaching and learning and would like to advise you of Canterbury Primary School's voluntary financial contributions for 2022.

Schools provide students with free instruction to fulfil the standard Victorian curriculum and we want to assure you that all contributions are voluntary. However, Canterbury Primary School Council wants to provide your child/ren with more. Without the support of our families through your contributions (both Curriculum Contributions and Other Contributions) and fundraising, we could not provide the quality and range of educational programs and resources that you and the school expect for your child.

School Council makes every effort to keep the cost of items and activities to a minimum and affordable for all parents.

Thank you to all of those families who have made a contribution to our school, these funds have been gratefully received and allowed us to:

- Refresh the take home readers for Prep – Year 2 students.
- Support the delivery and implementation of a school-wide spelling program, with Little Learners Love Literacy in Prep and Year 1, and SMART Spelling in Year 2 – Year 6.
- Provide an enhanced curriculum to all students, including the Makerspace and STEM learning.
- Purchase digital technology equipment and provide classrooms with access to an IT technician.
- Maintain our buildings and grounds, including routine and planned maintenance tasks. Contributions received also help us to maintain and care for our heritage listed buildings.

In total, these improvements are valued at approximately \$95,000.

Payment methods

Payments can be made online via Compass or by credit card at the school office from the start of the 2022 school year (31 January 2022) and **preferably before Friday 25 February 2022**. If paying at the school office, please enclose with payment the completed contribution schedule from Compass.

Financial Support for Families

Extra-Curricular Items and Activities

Canterbury Primary School offers a range of items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides in order to deliver the Curriculum and will be posted to Compass as **individual events and on a user-pays basis**.

Refunds

If a camp or excursion is cancelled or altered by the school, or a student is no longer able to attend part or all of the camp or excursion, our school will consider requests for partial or full refunds of payments made by parents/carers on a case-by-case basis taking into account the individual circumstances. Generally we will not be able to refund payments made for costs that have already been paid where those funds have already been transferred or committed to a third party and no refund is available to the school. Where possible, we will provide information about refunds to parents/carers at the time of payment.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
